If San Antonio voters pass the SAWS Accountability Act, we will:

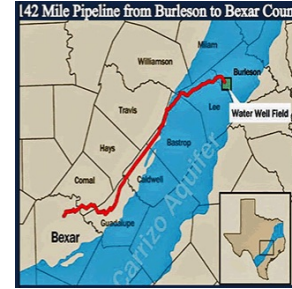
- ▶ Ratchet back SAWS General Manager Robert Puente's outrageous pay (\$600,000 per year) versus industry norm (\$250,000).
